# What is HITRUST CSF?

HITRUST Common Security Framework (CSF) is becoming the most widely adopted framework for the healthcare industry in the US.

The HITRUST CSF rationalises relevant regulations and standards and provides a common framework specific to the healthcare industry for managing security risks. By applying a single, comprehensive and certifiable framework to harmonise multiple regulations, standards and best practices, organisations can achieve a single assessment that may be reported in multiple ways for an 'assess once, report many' approach.

The CSF is not a new standard, but a certifiable framework designed to help vendors prove their security and for covered entities to streamline security reviews of their vendors.

Several of the largest global healthcare payers now require that their vendors obtain a HITRUST certification by 2017.
