# Benchmarking of IT applications for global EPC company

Case study on IT application landscape assessment and peer benchmarking



### **Background**

Client is India's largest engineering, planning and construction (EPC) company. PwC was engaged to create an IT application roadmap based on assessment of existing IT application landscape and comparison with global peers.



### Pain points

Client was using in-house developed IT systems, which had grown organically over a decade to support business requirements. The different components of the IT systems lacked integration, did not incorporate industry best practices, and in many cases were not user-friendly and consequently not used. Key issues faced by the client:

- Fragmented development of the IT system, resulting in absence of integration among different applications
- Functionality gaps in the existing applications to support complete business operations
- Manual operations in several process areas due to absence of necessary systems / inoperable systems
- Inadequate management information system (MIS) functionalities for consolidated reporting at site, cluster, and region level for projects
- Absence of robust controls in IT systems to ensure cost efficiency for labour, material and equipment

#### Our solution

- Assessed coverage of IT applications to identify gaps in the existing application landscape
- Conducted industry IT landscape comparison for 10 global peers through primary and secondary research
- Identified IT initiatives to address business-IT functionality gaps
- Created IT application roadmap to detail out enhancements required in the existing applications, and new applications required to bridge the functionality gaps
